FMAP Decision Packages

Summary:

Expenditures in foster care, subsidized adoption and subsidized guardianship are reimbursed, in part, through federal Title IV-E funds. This funding stream supports eligible expenditures in these programs for children who meet financial eligibility criteria, and whose case meets other non-financial benchmarks. Title IV-E matching rates are tied to the federal FMAP percentages for social services. Changes are incorporated into present law packages for each subsidized program. The projected FMAP for FY 2024 and FY 2025 is applied to FY 2023 base funding to determine the difference needed that is attributable to projected FMAP changes.

FMAP Adjustment Change Package Calculations:

- 1. Identify the base budget for each program
- 2. Remove estimated allocation of tribal benefits from the base (different and unchanging FMAP; applies to foster care only)
- 3. Apply FY 2024 FMAP to the base budget
- 4. Calculate the difference between base budget as funded and "new" FY 2024 base with anticipated FMAP
- 5. Apply FY 2025 FMAP to the base budget
- 6. Calculate the difference between base budget as funded and "new" FY 2025 base with anticipated FMAP
