PRACTICALLY SPEAKING

► HAVING A WAIVER ALLOWS THE STATE TO:

- EXPAND ELIGIBILITY -- INCOME AND RESOURCES RULES APPLIED IN THE COMMUNITY
- TARGET SERVICE GROUP ELDERLY, PHYSICALLY DISABLED
- EXPAND BENEFITS ADDITIONAL SERVICES TO KEEP INDIVIDUAL INTEGRATED IN THE COMMUNITY
- ABILITY TO RESTRICT ENROLLMENT

TARGET SERVICE GROUP

- ELDERLY (>65)
- Physically Disabled

ELIGIBILITY

- MEET NURSING FACILITY LEVEL OF CARE
- FINANCIAL ELIGIBILITY FOR LONG TERM CARE MEDICAID

GOAL

- TO PROVIDE SERVICES & SUPPORT TO INDIVIDUALS IN THE COMMUNITY TO DELAY OR PREVENT ADMISSION TO A NURSING HOME.
