Notification Date: Date SLTC was notified of the facility's closure

Termination Date: Date of facility closure and termination of the facility's contract with CMS

Licensed Bed Count: Total number of beds the facility is licensed/certified for by Montana/CMS

Occupied Bed Count: Total number of residents occupying facility beds at the time of announced closure

Skilled Nursing Facility: Number of residents transitioned from the closing facility to a skilled nursing facility

Swing Bed: Number of residents transitioned from the closing facility to a Montana Critical Access Hospital (CAH) swing bed

Assisted Living Facility: The number of residents transitioned from the closing facility to a Montana licensed Assisted Living Facility (ALF)

Group Home: Number of residents transitioned to a Montana licensed Group Home

Other: Number of residents who were transitioned from the closing facility to home or out-of-state

Pending: Number of resident transitions at the location continues to be tracked and final data is pending

- > To date, nine nursing homes have closed (or announced closure) in 2022
- > The majority of facilities closed had high vacancy rates based on licensed beds and reported low staffing levels and immediate resources

Valley View Estates (Hamilton)

Corporation: Goodman Group

• Licensed bed count 89; occupancy at time of closure 30

Hillside Health and Rehabilitation (Missoula)

Corporation: Goodman Group

• Licensed bed count 95; occupancy at time of closure 61

Cedar Wood Villa (Red Lodge)

Corporation: Lantis Enterprises

- Licensed bed count 76; occupancy at time of closure 21
- The June 2022 flood impact to the building prompted the facility's closure. Residents were relocated to sister-facility Eagle Cliff SNF in Billings, Mt.

Hi-Line Retirement Center (Malta)

- Licensed bed count 56; occupancy at time of closure 22
- The facility's decision to close was prompted by an *IJ determination by Montana's Office of inspector General Survey Team

The Centers for Medicare and Medicaid Services (CMS) defines Immediate Jeopardy (IJ) as "a situation in which the provider's noncompliance with one or more requirements of participation has caused or is likely to cause serious injury, harm, impairment, or death to a resident."

- 300 Long-Term Care Residents Impacted

Lake View Care Center (Big Fork)

- Licensed bed count 83; occupancy at time of closure 36
- Residents were relocated to sister-facility Heritage Place SNF in Kalispell, Mt 16 miles away.

Rocky Mountain Care Center (Helena)

• Licensed bed count 101; occupancy at time of closure 25

Beartooth Manor (Columbus)

Corporation: Lantis Enterprises

• Licensed bed count is 82 with an occupancy of 36 at the time of announced closure.
