## OFFICES OF PUBLIC ASSISTANCE CLOSURE INFORMATION

*DPHHS is closing 19 Field Offices of Public Assistance. The OPA office closures are part of the \$49 million in funding reductions to the DPHHS budget and represent about half of the total \$76 million cut to all state agencies. Prior to the session, DPHHS was facing a \$100 million funding reduction. However, that amount was reduced to \$49 million when Governor Bullock and the Legislature came to an agreement to balance the state's budget during the session using a combination of cuts, transfers and other legislation.*

*The offices listed below will be closed no later than January 31, 2018. The actual office closure dates vary by community. Some offices will offer limited office hours through January 31. Specific information is listed below.*
