## Definitions of terms:

- **DPHHS eLearn** - Main eLearning portal for the Department of Public Health and Human Services. <https://dphhselearn.org>.
- **Test site** - The test site will be used for creation and development of trainings. <https://testdphhs.moonami.com>.
- **ePass Montana** - State of Montana's single sign-on authentication solution developed by Montana Interactive.
- **Teacher** – The default role given to A default role which can be renamed within individual courses
- **Student** – A default student role can be renamed within individual courses
- **User** – Anyone with an account to login to DPHHS eLearn
- **Course** - An area where a teacher can add resources and activities for students to complete.

**Notice:** The security of information posted on the DPHHS eLearn site is not guaranteed. Course content **MUST NOT** contain personally identifiable information (PII) or personal health information (PHI). All content must also be ADA compliant.

DPHHS eLearn is the DPHHS Learning Management System. This site allows online training to maximize, stimulate, and facilitate knowledge and awareness in Public Health and Human Services of Montana.

A teacher has responsibility for the materials in their own course. They can also manage enrollments and change the layout of the course page. This quick start guide introduces Moodle's features to those with Teacher role.

## Become a Teacher

Teachers must have supervisor approval and submit an [OM300 form](#).

## Course set up

To request a new course, please use the [New Course Request form](#). Web Support will create a new blank course. Once created, the course can be built by the teacher. Courses may consist of discussion boards, course material, WebEx, Storyline2, PowerPoint, ArcGIS, Videoscribe, Prezi, just about any type of application or software you can imagine as a tool can be used on Moodle.

It is important to note that all courses must be designed to meet HIPAA and ADA requirements for accessibility.

Course sections may be renamed by turning on the editing and clicking the configuration icon underneath the section name. Sections may also be moved by drag and drop and sections added or removed by clicking the + or - underneath the bottom section.

You can also add elements known as 'blocks' to the right, left or both sides of your central learning area (depending on your theme).

## Course enrollment

Before a student can access your course, they must first be logged into the site, which uses ePass Montana.

The types of enrollment consist of:


- Self-Enrollment

- Request for Enrollment

State Employees and others with state issued login ids will access using the “Login with State Employee Account” option.

Username: state\C#

Password: same as Outlook password

Those without a State issued login id can create an account and use “Login with ePass Montana”.




Providing a link to your course directly with login instructions is recommended. Once the student has passed the login step, they will be taken to your course.

## Features

Moodle features such as forums or discussion blogs, quiz, resources, and certificates can enhance and drive your trainings.

## Tracking progress


If completion tracking has been enabled for the site and in *Course administration > Edit settings*, you can then set completion conditions in activity settings. A checkbox will appear next to the activity and a student may be allowed to tick it manually, or a tick will display once criteria for that particular activity have been met. This feature can be combined with Course completion so that when certain activities have been completed and/or grades obtained, the course itself is marked complete.



Chat, useful links, and video resources are just two more helpful tools to use.

## Restricting access

A course can be set to display everything to everyone all the time, or it can be very restrictive, displaying certain items at certain times, to certain groups or based on performance in previous tasks.

## Course Creation Best Practices

The adult pedagogy required for distance education and learning requires considerations of how adult learners learn, interact with other learners, and how adult learners interact with learning management systems. Adult pedagogy indicates that there are specific methodologies that enable learning across all platforms. When using an LMS there are some best practices to use from how the LMS is configured to the materials used.

### LMS Course Setup

DPHHS eLearn courses need to be configured to best meet the needs of the learner, in this case adult learners. The following table describes the basics of the best practices of a course design and configuration.

The description will also provide an overview of the course to the learner prior to enrollment.</p> <p>Clear navigation and overview/introductory materials help learners find what they need, reducing frustration. They help learners avoid missing important instructions or assignments.</p>
<b>Course Structure</b>	<ul style="list-style-type: none"> <li>• Be consistent in course layout design, module design, and materials</li> <li>• Use modules to chunk related materials</li> <li>• Text and materials that are to be read online should be short and to the point</li> <li>• Roles should be renamed to reflect the course: Teacher to Trainer Student to Learner</li> <li>• Course format (Grid, topic, etc.) should be decided with the overall course in mind</li> <li>• Enrollment methods reflect the needs of the course</li> <li>• Use file naming system that is consistent</li> <li>• Use the checklist if you need assistance See Appendix B</li> </ul>	<p>Course roles should be considered carefully. Adult learners generally do not like to be referred to as students. But they do not need to be called learners, for example of course dealing with nurses may rename the role student to nurse.</p> <p>The course format is important. Courses with lots of materials but not a modular format could go with a grid format. One with many modules should use the module format.</p> <p>Enrollment methods are designed to get the right learners into the right course.</p>

<b>Assessment and Measurement</b>	<ul style="list-style-type: none"> <li>• Completion criteria is clearly stated (You need an 80% or better, you must obtain an 8 out of 10 or better)</li> <li>• Assessments (assignments, exams, projects, discussions, etc.) are aligned with course outcomes</li> <li>• Assessments are varied, including formative and summative assessments</li> <li>• If proctored exams are desired, proctoring requirements are established with the testing coordinator and communicated in the syllabus</li> </ul>	<p>Clear expectations help learners succeed. Assessments should be aligned with outcomes to ensure that outcomes are being met.</p>
<b>Instructional Materials</b>	<ul style="list-style-type: none"> <li>• Instructional materials are in alignment with the course outcomes and module Outcomes</li> <li>• Instructional materials are appropriately cited</li> <li>• Copyright permissions for any borrowed images, textual content, film, or other source materials have been requested; in cases where permissions are denied or when fees are not feasible, the source materials in question are removed.
