Enclose Registration: Registration is only guaranteed upon receipt of registration fee. (If course is full when you register, you will be contacted about eligibility for another course.)

\$700.00 for Physician registration.

\$550.00 for Physician Extender Registration. A limited number of physician extenders are accepted into each course. Physician extenders are non-physicians; (eg. nurse practitioner, physician assistant) who are directly involved in the management of the trauma patient. Physician extenders are not eligible for verification from the American College of Surgeons, but will receive a certificate of participation.

\$350.00 for ATLS Refresher registration. Up to six physicians will be accepted at each course for an ATLS refresher. Refresher candidates are only eligible for the refresher course 6 months before their expiration date to 6 months past their expiration date. Candidates will attend on Saturday for approximately 4 hours for an update on 9th Edition ATLS materials and written and patient scenario tests.

\$350.00 for Auditor Registration. Up to four auditors are accepted into the February, April and May courses, *but not for the March and November courses.* "Auditors are nurses (non-midlevel) or EMT-Paramedics who are involved in the management of trauma patients. Auditors will be able to observe lectures and skills station but will not practice the skills. Not eligible for ACS verification

Advanced Trauma Life Support (ATLS) V9

Need:

- Injury is precipitous and indiscriminate
- The doctor who first attends to the injured patient has the greatest opportunity to impact outcome
- The price of injury is excessive in dollars as well as human suffering

Program:

- CME program developed by the ACS Committee on Trauma
- One safe, reliable method for assessing and initially managing the trauma patient
- Revised every 4 years to keep abreast of changes

Audience:

- Designed for medical providers who care for injured patients
- Standards for successful completion established for doctors
- ACS verifies doctors' successful course completion

Benefits:

- An organized approach for evaluation and management of seriously injured Patients
- A foundation of common knowledge for all members of the trauma team
- Applicable in both large urban centers and small rural emergency departments

Objectives:

- Assess the patient's condition rapidly and accurately
- Resuscitate and stabilize the patient according to priority
- Determine if the patient's needs exceed a facility's capabilities
- Arrange appropriately for the patient's definitive care
- Ensure that optimum care is provided

Student Course:

- Teaches medical core content in an interactive format
- Hands-on skills sessions in simulated trauma settings
- Successful completion status valid for 4 years from course date

Student Refresher Course:

- Provides doctors the opportunity to maintain a current status
- ½-day course format

Content overview, triage scenarios, written and practical tests included. Student and Instructor Re-verification: If you have taken the Student Provider Course or have re-verified at the Student or Instructor level in the past four years. This is for providers comfortable with minimal refresher material.

limited number of physician extenders are accepted into each course. Physician extenders are non-physicians; (e.g. nurse practitioners and physician assistants) who are directly involved in the management of the trauma patient. Physician extenders are not eligible for verification from the American College of Surgeons, but will receive CME and a certificate of participation.

\$350.00 for ATLS Refresher registration.

Up to six physicians will be accepted at each course for an ATLS refresher. Refresher candidates are only eligible for the refresher course 6 months before their expiration date to 6 months past their expiration date. Candidates will attend on Saturday for approximately 4 hours for an update on 9th Edition ATLS materials with written and patient scenario tests.

\$350.00 for Auditor Registration (available in Great Falls and Missoula courses only).

Up to four auditors are accepted into the February, April and May courses only, due to ATCN being held concurrently in Billings Courses. Auditors are nurses, EMT- Paramedics and others who are involved in the management of the trauma patient. Auditors will be able to audit all lectures and skills stations, but will not be able to attend written and patient scenario testing. They are not eligible for verification from the American College of Surgeons, but will receive a certificate of participation.

This two-day student course consists of core content lectures, case presentations, discussions, development of life-saving interventional skills, and practical laboratory experience. Following is a partial list of areas covered:
