**CONTINUUM OF CARE FOR
MONTANA STATE HOSPITAL MENTAL HEALTH GROUP HOME RESIDENTS**

- I. PURPOSE:** To define the continuum of care and movement of patients between levels of care at Montana State Hospital (MSH). Licensed Independent Practitioners, in consultation with their treatment teams, other treatment teams on the campus of the hospital, and the associated program managers, will identify and order the patient to be served in the most appropriate, least restrictive, treatment/rehabilitative setting available.
- II. POLICY:** Licensed Independent Practitioners will secure the most appropriate care setting for each patient by ordering, as described in this policy.
- III. DEFINITIONS:**
 - A. *Continuum of Care:* Levels of care offered at MSH (Mental Health Group Home beds and Hospital Treatment Unit beds).
 - B. *Montana State Hospital Mental Health Group Home (MSH MHGH):* The MSH MHGHs licensed under the Mental Health Center Group Home Standards.
 - C. *Hospital:* The treatment units in the main hospital at MSH, including A-Unit, B-Unit, D-Unit, E-Unit, Spratt Unit, and the Forensic Mental Health Facility.
- IV. RESPONSIBILITIES:**
 - A. Licensed Independent Practitioners will identify the appropriate placement in the continuum of care at MSH.
 - B. Program managers will maintain each care environment in a manner consistent with its role.
- V. PROCEDURE:**
 - A. The Licensed Independent Practitioner will make a determination as to the most appropriate setting to serve a patient's needs while on the campus of MSH.
 - B. The Licensed Independent Practitioner will utilize, as appropriate, the clinical team, review boards, and/or administrative consultation, in ascertaining the most appropriate care setting for their patient.

- C. The Licensed Independent Practitioner will place or change placement of a patient, in the MSH continuum of care by writing one of the following orders:
1. "Admission to ...; (Hospital/MSH MHGH)
 2. "PPV ...; (Hospital/MSH MHGH)
 3. "Transfer to...; (Hospital/MSHMHGH or MSHMHGH/Hospital)
 4. "Discharge to...; (Hospital/MSH MHGH)
 5. "Discharge from...; (Hospital/MSH MHGH)
- D. The Licensed Independent Practitioner may order a Pre-Placement Visit (PPV) at an MSH Group Home if necessary to monitor the patient's adjustment to a less restrictive setting. The Licensed Independent Practitioner will determine the most appropriate length of time for such a visit and include the time in the order.
- E. The attending Licensed Independent Practitioner may include additional orders designed to help the patient adjust to the less restrictive setting or designed to secure the necessary individualized care.
