

PART C EARLY INTERVENTION

Montana Milestones is the Part C Early Intervention Program for Infants and Toddlers with Disabilities, part of the federal *Individuals with Disabilities Education Act (IDEA)*.

Early intervention builds upon and provides supports and resources to assist family members and caregivers to enhance children's learning and developmental through everyday learning opportunities.



MONTANA MILESTONES

PART C EARLY INTERVENTION

- Early Intervention Services to infants and toddlers birth to age 3.
- Eligibility:
 - ❖ Type 1: based on an established condition such as down syndrome.
 - ❖ Type 2: 50% delay in one developmental area or a 25% delay in two developmental areas.
 - ❖ Reviewed annually, based on developmental assessments.
- Services are entitled to eligible infants/toddlers.
- Services are delivered in the family home using a primary coaching model.

STATE PLAN MEDICAID SERVICES

➤ Targeted Case Management

- ❖ Must meet State definition of having a developmental disability/intellectual disability.
 - ❖ Eligibility established by DDP eligibility specialist
 - ❖ Vineland II Adaptive Behavior Assessment
 - ❖ Recent Psychological which include IQ testing and subtest scores
 - ❖ Social history is helpful
- ❖ Service is entitled for persons 16 and older if receiving no other case management service
- ❖ Four key activities
 - Comprehensive assessment and periodic reassessment
 - Development and periodic revision of a specific care plan
 - Referral and related activities
 - Monitoring and follow-up activities
- ❖ Providers cover a specific geographic area.

PROPOSED STATE PLAN SERVICES FOR AUTISM

- Individuals up to age 21
- Independent, conflict-free diagnosis
- Two levels of service
 - ❖ Low Intensity
 - ❖ Treatment Plan
 - ❖ Implementation Guidance
 - ❖ Intensive Treatment
 - ❖ Treatment Plan
 - ❖ Implementation Guidance
 - ❖ Intensive Intervention up to 20 hours/week
- Evidence-Based Practices
- Utilization Review by independent contractor



COMPARISON

Medicaid Waiver

- Institutional Level of Care
- Services not available through a State plan
- Limit number of enrollees
- Waiver of deeming
- Can waive statewideness

Medicaid State Plan

- Medical Necessity
- Mandatory and Optional Services
- Cannot limit enrollees
- No waiver of deeming
- Must serve all of the State

0208 COMPREHENSIVE WAIVER SELECTION PROCESS

- Waiting List: approximately 1100 individuals
- Selection: length of time on waiting list
- Emergency Selection:
 - ❖ Finding of maltreatment as determined by Child Protective Services or Adult Protective Services
 - ❖ Death or inability of the person's primary caregiver to provide care and no alternative caregiver is available
 - ❖ Is there a lack of appropriate placement for the person due to loss of housing or imminent discharge from the temporary placement or hospitalization
- Institutional Placements:



PLAN OF CARE

Individualized Family Support Plan

- Infants and Toddlers/Part C/Montana Milestones
- Family Education and Support
- Waiver Individuals up to age 16
- Annual plan of Care
- Six-Month Review

Personal Supports Plan

- Individuals 16 and older receiving case management
- Individuals receiving waiver services 16 and older
- Annual Plan of Care
- Quarterly reporting on status of outcomes

WHAT WE CAN'T DO! JUST TO NAME A FEW!

- Require individuals to accept services in a home and community-based waiver
- Require a provider to serve an individual
 - ❖ Discontinuation Rule
- Provide housing/shelter
- Become a person's guardian
- Prevent individual's from making bad decisions
