 - Restricts members to a single waiver case manager provider.
 - **Amendments to the Concurrent 1915(c) Home & Community Based Services (HCBS) SDMI Waiver:**
 - Approval effective January 1, 2018 through June 30, 2020, to increase unduplicated member counts.
 - Approval effective October 1, 2018 through June 30, 2020.
