## WAIVER FOR ADDITIONAL SERVICES AND POPULATIONS (WASP) Severe Disabling Mental Illness (SDMI) Criteria

To qualify for the WASP waiver SDMI, the applicant must meet both diagnosis and functioning impairment criteria.

### Functioning Impairment Criteria

*Must meet two of the following:*

1. A medical professional with prescriptive authority has determined that medication is necessary to control the symptoms of mental illness;
2. The person is unable to work in a full-time competitive situation because of the mental illness;
3. The person is unable to work in a full-time competitive situation because of the mental illness;
4. The person is unable to live independently due to mental illness;
5. The person is unable to care for themselves due to mental illness; and
6. The person is homeless or at risk of homelessness due to the mental illness.

Please note the following important guidelines:

1. These diagnostic specifiers do not qualify as SDMI
  - mild, not otherwise specified (NOS), or unspecified;
  - physiological disturbances; or
  - physical factors.
2. It is the responsibility of the diagnosing practitioner to select the correct ICD-10 code and specifier that is also supported in the documentation.
3. If the primary diagnosis is not the qualifying ICD-10 code with the appropriate specifier and supported in the documentation, the application will be denied.
