Dear Region Staff and Providers,

Happy New Year! Go live for MedCompass is set for February 16, 2021. As you prepare for using MedCompass beginning February 16, we want to provide you with a description of what "go live" means for you and your everyday work. Below are descriptions of what it means to go live in MedCompass beginning February 16.

Secure Communications (S-Comms)/ Secure Messaging	MedCompass
T-Logs/Provider and Case Manager Case Notes	MedCompass
Assessments	MedCompass
Incident Management Activities	Therap
PSPs scheduled in February and March 2021	Therap
PSPs scheduled in April 2021	MedCompass
Cost Plan changes/additions	MedCompass
Level of Care tasks	MedCompass

Targeted Case Managers need to open all assessments, Including the PSP document, for April PSPs during the week of February 15th. It is important for this action to be completed by the end of the week so providers can begin working on the documents they need to complete by April PSP meetings. A reminder, only one user at a time can be in a member's PSP Assessment in the MedCompass System. More information will be available soon on how this will be coordinated.

Data Extraction from Therap to MedCompass, Important Dates

All data from Therap from July 1, 2018 through February 16th, 2021 will be converted to MedCompass and available for you by March 5th. PSPs scheduled in February and March 2021 that are inputted into Therap will be converted to MedCompass (by AssureCare) by May 14, 2021. After go-live, anything entered into Therap, except for incident management and PSPs, will not be migrated from Therap to MedCompass.
