

Approved Point-of-Care Urine Drug Tests (UDTs) for the Montana HEART Contingency Management Program

Montana DPHHS has identified the point-of-care urine drug tests (UDTs) that meet program specifications, as listed below. Montana DPHHS reviewed and approved these specific UDTs because they meet the cut-offs for amphetamine (500 ng/mL), cocaine (150 ng/mL), methamphetamine (500 ng/mL), opiates (300 ng/mL), oxycodone (100 ng/mL), and fentanyl (1-5 ng/mL) that provide the most simple, accurate, and accountable results. It is important and required to use only these approved UDTs to ensure regulatory alignment and provide the best service to our members.
