Update on status of Peer Support Medicaid Policy Revision Recommendations

• Issac Coy believes we should hear back soon from Medicaid. It was submitted in December but there has been a lot of things up in the air and needing to wait for the Governor to modify and sign HB 2. As this will be a fairly fiscally neutral request to 1. Expand settings that can bill for peers 2. Allow for group peer support billing and 3. Modify what dx can determine eligibility, Issac believes that the changes may be approved. Issac has also had conversation with Jamie about other potential funding sources including prevention funding, block grant funding, or Behavioral Health System for Future Generations Fund. Might also pivot to fund a smaller pilot program to gather data.
