Center staff can connect you with providers, programs, or other families dealing with issues similar to the ones your family is facing. We can research answers to your questions about services and resources available in Montana. The answers may not be the ones you want, but we can help you explore alternatives. Additionally, Montana F2F also collects family stories & shares identified needs and roadblocks to care with agency heads, legislators, & others who influence systemic change. Collectively, family voices can improve access to healthcare and encourage funding for meaningful supports for our children and youth with disabilities & diagnose.

Montana Department of Labor & Industry

Work Incentives Planning and Assistance

Our mission is to foster the growth and development of children who are hard of hearing or deaf, have low vision or blindness, or who are deafblind. MSDB believes that all children are capable and confident and able to become successful citizens. We embrace the whole-child philosophy of education, which includes sensory-specific access to communication and curriculum in safe learning and living environments.

MSDB is the statewide resource for families and schools. We serve children who are identified with hearing and/or vision conditions, aged birth through 21 years, at no cost to families. Children who qualify for our services may attend classes on our campus, in their own local schools, or a combination of both. MSDB has Outreach Consultants who are specifically trained to work with children who have hearing or vision challenges. Our Outreach Program is statewide and offers consultative support to families, students, and local school districts.
