## **NATIONAL NEWS**

Much of our country has been suffering from the extreme heat and some areas with very severe weather. We hope you all are staying safe and comfortable. Our office will be closed on Friday, July 4<sup>th</sup> for the federal holiday. Be safe out there and enjoy as we celebrate our nation's birthday.

### *Medicare & Social Security Trust Funds*

In mid-June the Medicare and Social Security Trustees released their annual reports on the financial status of the trust funds. The Medicare Trustees project that the Medicare Hospital Insurance (HI) trust fund will be insolvent in 2033 with a 75-year shortfall of 0.42 to 1.28 percent of payroll. Meanwhile, total gross Medicare spending will continue to grow. The 2025 Social Security Trustees Report projects Social Security is only eight years from insolvency. ### *Senate Medicaid Proposal*

Some key takeaways:

- Increases eligibility checks to every six months (from 1 year) for the expansion population
- Disallows federal reimbursement for Medicaid coverage until an individual has proven citizenship
- Work/community engagement requirements for able bodied adults without dependents
- 80 hours a month required

Some Exemptions:

- Veterans with a disability rated as total, and,
- Individuals who are blind, have a substance use disorder, disabling mental disorder, a physical or intellectual disability that significantly impairs their ability to perform one or more activities of daily living, or a serious or complex medical condition.

Last Thursday plans to bring the bill to a vote in the Senate hit a snag when the Senate Parliamentarian rejected key provisions in the bill including a plan to cap states' use of health care provider taxes to collect more federal Medicaid funding, a proposal that

would have generated hundreds of billions of dollars in savings to offset the cost of making President Trump's corporate tax cuts permanent.

### *Supreme Court Ruling on Combat Related Special Compensation*

The US Supreme Court ruled unanimously that a six-year time limit under the Barring Act does not apply to claims for combat-related special compensation (CRSC), paving the way for thousands of retired service members to receive retroactive payments. The decision is expected to affect over 9,000 veterans and could lead to more than \$50 million in retroactive payments. Advocates hailed the ruling as a major victory for medically retired veterans.

### *DOL Secretary Calls for Modernization*

DOL Secretary Lori Chavez-DeRemer called for modernization in her testimony before Congress in support of the Trump administration's proposed 2026 budget, which would cut \$50 million from OSHA and reduce its workforce by over 200 positions. Despite the reductions, she argued that modernizing operations — through digital tools, data-driven inspections, and regulatory streamlining — would allow OSHA and MSHA to maintain enforcement capacity. The strategy shifts focus from aggressive enforcement to increased compliance assistance, hoping to help employers voluntarily meet safety standards.

### *DOE Repeal of 504 Requirements*

The Department of Energy has released a "Direct Final" rule repealing section 504 requirements from new DOE buildings. The Department's rule cites that the section 504 requirements are overly burdensome and redundant when contractors already must be compliant with section 10 CFR 1074.1 of the Code of Federal Regulations (CFR). The Department is repealing only 10 CFR 1040.73 which is the more specific section linking the accessibility requirement to 504 specifically instead of 1074 which is broader.

### *DOT Pauses Enforcement of Airline Wheelchair Policy*

Department of Transportation has extended pause on enforcement of airline wheelchair policy. The Biden Administration promulgated rules which detailed how airlines must manage individuals' mobility devices and consequences and liability for losing or damaging those devices. The Trump administration initially delayed the rule until around this time but has now extended the delay to August 1 citing concerns about the ability to comply from the airlines.
