RSA & ED UPDATE

On September 13th RSA shared an updated version of the Case Service Report (RSA-911) Data Dashboards including data reported for the fourth quarter of PY 2023. This workbook includes performance results for all VR agencies and seven previous quarters of RSA-911 data.

Per RSA, 57 of the 58 2024 State Plans have been reviewed and approved. Seventeen of these have been conditionally approved. RSA hope to complete the review of the last plan by the end of the month. They will then be published on the WIOA State Plan Portal.

QM, QE, and NTACTION-C will begin their fifth and final year on their five-year grants on October 1, 2024. If you have TA needs and have not talked with them already now is probably a good time to reach out to them to get on their docket for Year 5.

VRTAC-QM has made available the VR Wellness Check which is a self-assessment tool for vocational rehabilitation (VR) agencies to determine their progress in achieving the gold standard practice in multiple domains related to the quality program and performance, and fiscal and resource management of the VR program. It can be completed by an individual or group of individuals in a VR program. Almost 30 agencies have started the assessment with 87 users checking in from those agencies.

Research from the [Rehabilitation Research and Training Center \(RRTC\) on Employment of People who are Blind or Have Low Vision \[click.icptrack.com\]](#) was highlighted in an article, [Remote sighted assistance app use and thoughts about "sighted" assistance from artificial intelligence \[click.icptrack.com\]](#), in the Fall 2024 issue of AccessWorld. The article covers findings from the RRTC's survey of Access Technology in the Workplace about the use of remote sighted assistance apps, including those that use

artificial intelligence. The survey found that the apps were used daily by respondents, including at work, and those who tried apps with AI were positive about its impact.

LONG COVID UPDATE

Long COVID prevalence, disability, and accommodations: Analysis across demographic groups. Journal of Occupational Rehabilitation, Volume 34(2), Pgs. 335-349. NARIC Accession Number: J94090.

New to the NARIC collection, this NIDILRR-funded study examined the prevalence of long COVID across different demographic groups in the United States and the extent to which workers with Long COVID-related impairments engaged in pandemic-related remote work.

Using data from the Household Pulse Survey and Current Population Survey, results indicated that women, Hispanic people, sexual and gender minorities, individuals without 4-year college degrees, and people with preexisting disabilities are more likely to have long COVID and to have activity limitations.

This study found that people with disabilities were less likely than people without disabilities to perform remote work. It is possible that people with disabilities are clustered in jobs that are not amenable to remote work. Employers may consider other

accommodations, such as shorter workdays and flexible scheduling, to hire and retain employees who are struggling with the impacts of long COVID.
