Subject Line for Email: UAT Progress Update, Ensuring Sound Business Processes are Working

Dear Region Staff and Providers:

User Acceptance Testing is doing its job! Thanks to the staff participating in Phase 1 of o2o8 UAT, we are identifying what is working well in MedCompass and what isn't working. The UAT Group is working through the business processes to ensure MedCompass can support our work. Until we can ensure all of the business processes are functioning and have been tested from beginning to end, we are delaying implementation. That is our goal, to ensure sound business processes are working for our staff so you can better serve our members. In order for the UAT Group to complete its work, we will be delaying the start of Phase 2 of o2o8 UAT until August 11, 2020. What does this mean for you? Phase 2 of UAT will take about two to three weeks, which pushes out our implementation date. We are taking a cautious approach with moving forward with implementation in order to ensure MedCompass can support the important work you do with our members. We committed to get you training information out as soon as possible. Our training dates and plans have changed, due to Phase 2 of UAT being pushed out until mid-August. I will keep you as up to date as possible, giving you updated training and implementation dates as those are set. Thank you for your continued patience.
