Work group Discussion

Reports from work groups and next steps with timelines:

- 1) Workforce Increase multidisciplinary engagement and collaboration. Finished Brochure update (Kalli Decker), Introduction of Josh Kendrick for PD. Kalli Decker is teaching a Home Visiting Course, possible opportunity.
- 2) Coordination Improve transitions for children and families exiting Part C services and supports.

Transition workgroup (Shari Northcott). Work with Family Outcome Survey (turning 3 and leaving to increase representation). Development of procedure for transition from Part C to Part B. Late referral work. Part C guidance is within 90 days, work is 91 to 120 day is being developed.

Part C Updates

Part C Needs Assessment Update:

Develop a landscape of our state, to improve access to Part C services. (see slide presentation)

Survey went out to El professionals, Healthcare providers, Childcare. Review of survey (400 responses collected, April 3 -May 30). See breakdown of participants from slides.

Focus group held in Billings, Bozeman, Great Falls, Helena, Miles City, Missoula. 50 participants, including 13 participants virtual.

Extant Data reviewed from: March of Dimes Montana Report Card, Early Childhood Homelessness State Profile (2021), Montana Maternal, Infant, and early Childhood Home visiting (MIECHV) Statewide Needs Assessments Update (2020), The Office of Head Start Program Information Report.

Summary of Key findings from Needs Assessment (See slides from UM)

Childcare Resource & Referral regions do not align with Part C regions.

Healthcare voice was not strongly represented in focus groups.

Need for consistent, clarifying language around early intervention terms, definitions, procedures, resources.

63% of childcare respondents reported not using a screening tool.

Primary areas need PD in Child Development (29%) and Family/community partnerships. (21%)

Need for training on selection, interpretation, and use of screening tools.

Enhance Collaboration Through Awareness Campaigns. (See slide from UM)

Explore New Systems for Referral, Training, and Identification. (See slide from UM)

Opportunities to Collaborate within and across Montana agencies through partnership and community organizations and stakeholders.

Review of STARRS or QRS (Quality Rating Systems) Madison Diederich.

FFY 2022 Part C Annual Report Review (APR)

The data management system working on implementing a versioning up of the system that will help regional programs with data entry and help to ensure there is valid and reliable data.
