Review Updated Strategic Plan Work Plan

- Josh K. and Heather S. discussed the completed, in-process, and not started goals and plans compared to the last CTF meeting in March.

• Limited Solicitation Grants Report

- o Josh K. discussed the CTF Board committee choices for the \$5,000 grantees.
 - Anaconda Family Resource Center
 - Goals are to establish a referral and release of information process for families in need. Whild also connecting referred families with services and supports provided both internally and externally.
 - Outcomes will be referred parents will work with Anaconda FRC staff to address any risk factors, and also ensuring that the referred parents have better skills with which to find resources and parent their child.
 - Ealy Childhood Coalition of Beaverhead County
 - Main goal would be to remove barriers for caregivers who are wanting to attend parent educational programs.
 - The outcomes would potentially be increased capacity for reaching parents of children by providing means and childcare during the educational programs, and helping parents develop parenting skills and better understanding of practical tools.

- Missoula Public Health
 - Goals would be to identify family needs, identify current supports/services, identify possible gaps, and eventually develop a vision for coordinating the parent support system.
 - Outcomes would be identified by a clear and complete parent support plan for adoption and a stronger navigation for parents and caregivers. With the overall outcome being most of the participating organization working collaboratively to implement the action plan in the future.
- Safe Harbor of Lake County
 - Goal would be provision of group and mental health support for caregivers and children who are taking shelter following domestic violence.
 - The protentional outcome would be adult and child survivors of violence being able to participate in a mealtime and group activity with a professional therapist.
- Toby's Home
 - The main goal is training of early childcare provides, educators and facilities on trauma informed policies and practices.
 - The desired outcome would be for professionals and community members to understand the impact of ACE scores on child development.

Contracted Programming for State Fiscal Years 2025-2029

- Josh K. brought forth 3 possible options to change the funding protocol for state fiscal year 2025.
- o CTF Board decided to move forward with option three.
- Option three being:
 - Available funds: up to \$160,000 per year.
 - Contracts would have to complete an RFP for a three-year term with an optional extension for two-years.
 - Funding period would officially be 7/1/2024-6/30/2027 (SFYs 25-27), but there is the option to get an extension for another two years (7/1/2027-6/30/2029, SFYs 28-29).
 - Funding would be up to \$32,000/yr per contract.
 - Total initial contract value: \$480,000 over three years; additional contract value of \$320,000 over two years.
- Teresa K. made a motion to choose option 3 (as described above)
 - Elizabeth S. seconded the motion.
- An oral vote was taken. The choice to move forward with option three was accepted unanimously.
