Call to Order

EMS program update was provided by Shari Graham.

Frontier EMS Leadership Academy – DPHHS FLEX program is currently working on contracts with the six EMS agencies and the Montana Office of Rural Health.

DPHHS has sent a survey to collect data from ground ambulance services to determine the fiscal impact of implementing a Ground Ambulance Medicaid Supplemental Payment program. They are also seeking information for treat in place services. This information may lead to the development of a treat in place payment structure.

EMSC – NEMSIS has developed a <u>NEMSIS Pediatric Dashboard</u> that contains national level EMS data measures specific to pediatric patients.

- AED Pad requirement changed to: Adult and pediatric or combo pads Passed
- ALS Kit Requirements create a table for each crew level that reflects required ALS equipment by crew configuration level – Passed
- Gowns changed to Protective Gowns Passed
- Rolled Elastic Bandages remove from required list Passed
- Change Cervical Collar Requirement to: "Materials or devices that can be utilized to provide spinal motion restriction of the cervical, thoracic, and lumbar spine for neonates to adult." – Passed
- Table 9 Ambulance Specifications Add the following list to Table 9 as required vehicle components:
 - Emergency warning lights
 - Windows
 - Head lamps
 - o Brake Lamps
 - o Parking Lamps
 - o Back-up lamps
 - o Tail lamps
 - o Turn signals
 - o Side marker lamps
 - Hazard lamps
 - o Horn
 - o Siren
 - Spot lamp

• Discussion regarding removing the requirement for pediatric equipment for agencies who primarily respond in the roll of wildland fire EMS support. EMSAC decided not to act on this proposal. Agencies could pursue individual waivers.
