

FCSS creates two types of forms. The first type are forms where there is either a statutory or rule authority stating that inspections must be done on a form approved by the department. Those forms are listed in Table 1 below, when possible a link is provided to the Sanitarians Resource page so that you can download the form. If the form you are using is not on this list please let us know. We have recently reviewed approved a number of forms for counties and will continue to do so as requested. The second type of form is a form that we provide as a service. These forms can be found in Table 2, we recommend that you use these forms however their is not a statutory or rule requirement that you do.
