# **Public Health Controls**

- (2) free of harborage for insects, rodents and other vermin

- (4) CG spaces clearly marked with i.d. number or symbol
- (5) TC lots clearly marked with address or i.d. number

# **Guest Registration**

## 37.111.225

(1) registration kept  $\geq 6$  months; includes name and permanent address of each occupant; make, model and license number of trailer and tow vehicle; date of arrival and departure

## Animals Running at Large

## 37.111.226

(1) pet animal limited to tenant's lot, unless leashed; not allowed to run at large or commit nuisance

## Service Buildings and Other Facilities

## 37.111.230

- (1)(b) smooth, non-absorbent, easily cleanable surfaces in all plumbed areas; showers have non-slip surfaces and ventilation; windows, doors and other openings must be screened or kept closed
- (1)(e) clean and in good repair; showers, toilets and lavatories cleaned with disinfectant products
- (1)(f) hand cleaner and toilet tissue provided
- (2)(a) cooking or shelter house for common use cleaned after each day's use
- (2)(b) cooking, eating and drinking utensils provided must be non-toxic, durable, easily cleanable; washed and sanitized by campground employees after use
