**Definitions**  
 Off-Premises Liquor License - Purchase the item and take it home to be consumed some place other than where purchased  
 On-Premises Liquor License - Purchase the item and drink it there, a bar, restaurant, casino - ONP account type  
 Brewery - Makes the beer at this location  
 Taxes are billed through Accounts Receivable  
 Catering endorsements are added on to the existing license. The county specialist will assist with these endorsements  
 Vendor Reps example: salesman who goes to business requesting the store sell their product

\* **Out of Office Backup**  
 \*\* **Backup** - Used only if the specialist is out of the office and the request is immediate - ex: closing on a sale  
 If you cannot reach the specialist named, try the named backup specialist immediately
