- Help identifying things in your home that may make your asthma worse
- Custom asthma education
- Educational resources and referrals to community services
- Individual help with managing the medical system
- Free allergen proof pillow and mattress covers
- Free air filter for those with animals or smokers present in the home
- **All asthma home visiting services are offered at no cost to the program participants**

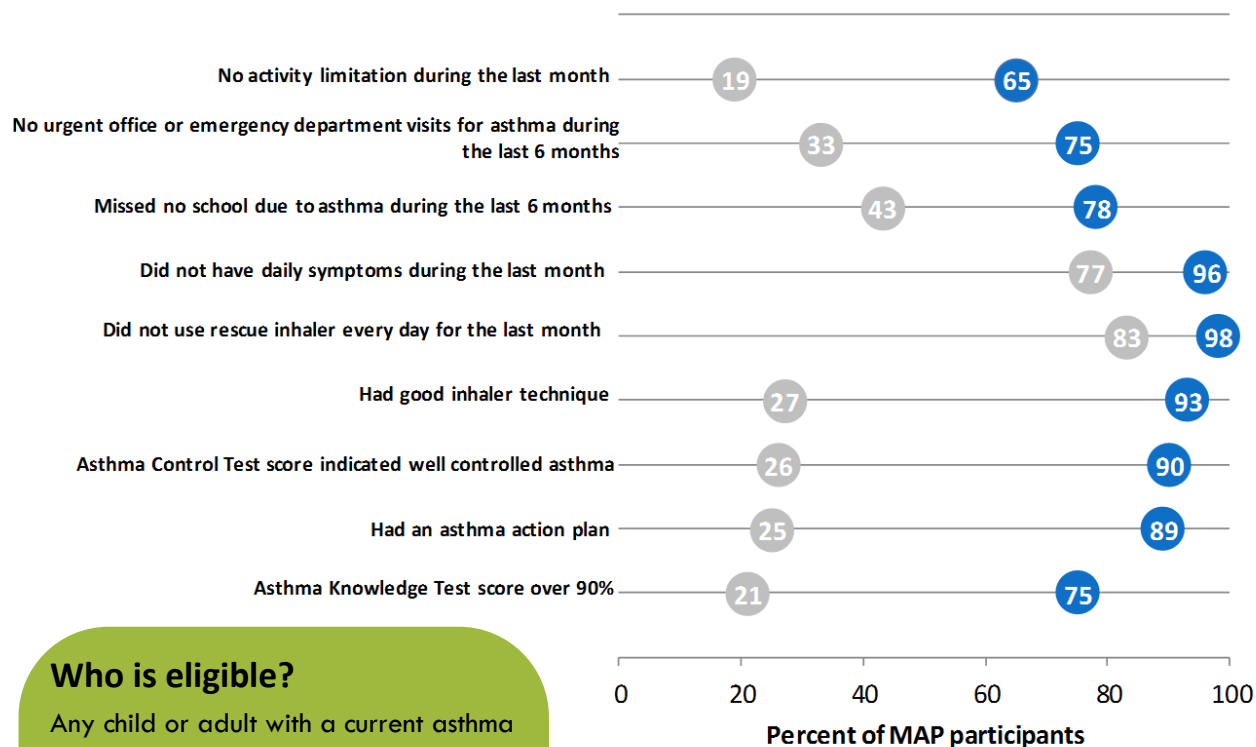
“Not only has my daughter’s health improved, **the whole family has benefited** from various environmental changes they made after an environmental home assessment.”

Who is eligible?

Any child or adult with a current asthma diagnosis who has had either:

- an emergency department visit, hospitalization or unscheduled medical office visit for asthma
- OR
- an Asthma Control Test score of less than 20 in the last year

Adults or children who do not meet these requirements are eligible for MAP with a direct referral from their healthcare provider.

- * Avoid missed school/work days
- * Limit the number of days with asthma symptoms
- * Learn how to properly use asthma medications
- * Create a plan to manage asthma
