

Prioritization criteria: Weight 1

Magnitude

- How many people are affected?
- Are people in Montana suffering more due to this issue relative to other places?

Seriousness

- How much does the issue affect quality of life and life expectancy?
- To what degree do local communities perceive this issue to be affecting health?



Prioritization criteria: Weight 1.5

Feasible Strategy

- Are there resources, funding and partners available to address this concern?
- Where can we move the needle?
- Will this issue benefit from a collective action approach?
- Are there policy or environmental changes that could affect the outcome?

Emergence/Urgency

 Is this a new or growing topic that needs to be addressed in the near term?




Leading causes of death

The two leading causes of death in Montana in 2021 were heart disease and cancer. However, rates of death in Montana from cancer were lower than in the U.S. overall.

Montanans had significantly higher rates of death due to accidents, chronic lower respiratory disease (CLRD), suicide, and chronic liver disease than in the U.S. overall.

Median age of death, all cause, 2017-2021:


- White Montanans
 - Male: 75 years
 - Female: 81 years
- American Indian Montanans
 - Male: 60
 - Female 64





Prioritization Criteria Exercise 34 responses received






Results of 1st Round of Prioritization

Intersection

- Is the topic amplified by other factors to create a greater issue?
- Will addressing this issue also positively impact other health concerns?

Equity

- Does the issue affect some population groups more than others in ways that can be changed?
- Are there institutional policies and practices that could be changed to create better outcomes for groups experiencing disparities?






