Reason for Supplemental Notice

On February 20, 2026, the Department of Public Health and Human Services (department) published MAR Notice No. 2026-323.1 regarding the public hearing on the proposed amendment and adoption of the above-stated rules, in the 2026 Montana Administrative Register, Issue No. 4.
