- 1. Achieve minimum compliance with the 21st Century Cures Act
- 2. Receive CMS approval for Operational Readiness and Certification
- 3. Where possible, reduce the administrative burden to Providers while maintaining compliance with the 21st Century Cures Act
- 4. Ensure that we achieve compliance with any guidance provided by the Federal Office of Inspector General related to EVV

- 1. EVV Department Survey
  - Was sent out on 3/3/23 by our program staff
  - The purpose of this survey is to collect information, at the request of a legislative committee, from Montana Medicaid providers to identify if providers already have an EVV system or if they intend to use the EVV solution provided by the Department.

#### 2. Netsmart Provider EVV survey

- A notification will be sent out in late March to participate in a survey.
- This survey allows Netsmart to determine if you have an existing EVV system, plan to acquire an EVV system or if you plan to use the Department's EVV system. If you have or plan to acquire an EVV system, Netsmart will begin communicating with your Vendor and providing next steps.

#### 3. Netsmart Alternate EVV Vendor survey

- A notification will be sent out in early April to participate in a survey.
- This survey allows Netsmart to gather information related to your Alternate EVV Vendor. Netsmart will then be able to start
  communicating with your Vendor to register their system and being the process to establish integration with to send EVV visit
  information.


