Montana Governor's Challenge Mission

- Task Implement a suicide prevention program for Montana's Servicemembers, Veterans and their Families (SMVF) that addresses the root causes of suicide through identification and screening for risk, building protective factors and facilitating care transitions for those determined to be at risk and by providing safe storage and/or disposal of lethal means for individuals in crisis.
- **Purpose** To reduce the number of suicides among the SMVF community in Montana and to build a network of protective factors to reduce suicide risk.
- **Endstate** The suicide rate for SMVF in Montana lowered to below the state rate and a statewide network of providers and protectors established to keep it that way.

Program History

- Montana in initial tranche of Mayor's Challenge in 2018. (Helena and Billings)
- Montana joins Governor's Challenge under Governor Bullock in 2019; MG Quinn (MTNG TAG) leads delegation to initial policy academy.
- Funding for implementation comes from HB696 (Version 2019) and provides \$250K granted to: L&C County Health Department, Riverstone Health (Yellowstone County), Billings Urban Indian Health Center, Yellowstone United Way, Dog Tag Buddies, Veterans Navigation Network.
- Among the programs developed: ATQ and Military Strong(In Yellowstone and Lewis and Clark Counties) and VA-led CPSS/PC program.

HB696 funding expired on June 30, 2021.

Current Project Status

Almost complete turnover of personnel from original GC Stakeholder's group; COVID effect.

New GC 2.0 team began SAMHSA/VA academy process in 2022.

Final action plan validated at implementation academy in February 2024.
